

The Centralized Admission Process (CAP) for polytechnic admissions in Maharashtra involves several key steps, including **online registration, document verification, and option filling**. Candidates must first register online on the Directorate of Technical Education (DTE) website dtemaharashtra.gov.in, providing personal, academic, and communication details, and uploading required documents. Following this, they need to visit a designated Facilitation Centre (FC) for document verification and participate in option filling for their preferred polytechnic courses. Detailed Steps:

1. Online Registration:

- Candidates must register on the official DTE website, dtemaharashtra.gov.in, creating an account and filling out the online application form. [[1](#), [1](#), [2](#), [2](#)]
